We began discussions with in 2023. I was introduced to Steven Tupponce who is the Director at Upper Mattaponi Indian Tribe Health Services. We had one discussion in 2023 regarding Steven's intent to bring on dental services at his clinic. There was a collective pause and the conversation resurfaced when Steven's group reached out and asked if we could continue the conversation and included two new members of their team (Donna Kellum and Nicole Beverly). We met again with UMIT and they discussed their desire to "go live" with their dental clinic in October of this year. They also briefly discussed their AIR (all inclusive rate) and the uniqueness of their program because of their 638 contract. In addition to meeting with UMIT, we also met with Nansemond Nation who operates in Portsmouth. They are looking to bring on dental services in October of this year as well. Both clinics requested the necessary credentialing paperwork to begin credentialing their dental provider.
